Enough is enough, The City of Reno has allowed the building of several large apartment complexes to be constructed on Selmi Dr. without the benefit of adequate roads and enforcement to handle what we already have. Currently there are 5 vehicles that are either NOT licensed, have expired plates or no plates. Yes Code enforcement did come out and tag one of them, two weeks ago and still it sits. We have complained about the speeding and nothing is done to alleviate the situation. It is not if a child is killed on this street it is when. We have complained a number of times to no avail.
