

## **B.1 Approval of Privileged Business Licenses**

### **B.1.a New - Alcohol**

1. Plaza Resort Club, LLC, Max Haynes, 121 West Street - Bar and Packaged Beer and Wine (For Possible Action) [**Ward 5**]
  - *Site visit by staff – This is an existing resort located on West Street adding on-premise alcohol service and off-premise beer and wine sales. The application is for a bar license and a packaged beer and wine license.*
2. Escape Lounge, Michael Boland, 2001 East Plumb Lane - Bar (For Possible Action) [**Ward 3**]
