

**B.1 Approval of Privileged Business Licenses**

**B.1.a New - Alcohol**

**1. The Refuge Spa, Nyla Allen, 1 South Lake Street - Bar (For Possible Action) [Ward 3]**

- *Site visit by staff – This is a new spa with alcohol service located in the Renaissance Reno Downtown Hotel. The application is for a bar license.*

**B.1.b New - Cabaret**

**1. Round 1 Bowling & Amusement, Shintaro Kaji, 5400 Meadowood Mall Circle - Cabaret (For Possible Action) [Ward 3]**

- *Site visit by staff – This is a new family entertainment center locating in the former Sears Store at Meadowood Mall. Tenant improvements underway at time of site visit. The application is for a cabaret license.*

**B.1.c New - Gaming**

**1. Mixers, Daniel Jones, 2900 Clear Acre Lane, Suite J - 8 Slots (For Possible Action) [Ward 4]**

- *Site visit by staff – This is an existing bar switching from a slot route operator to participation ownership located in the University Village Shopping Center. The application is for eight slots (restricted gaming).*

- *Site visit by staff – This is a change of ownership and location for an existing pawn license formally known as Pawn World co-locating with Palace Loan and Jewelry. The application is for a pawnbroker license.*

**1. Reno Elks Home Company, Frank Reynolds, 597 Kumle Lane - Fraternal Liquor (For Possible Action) [Ward 2]**

- *Site visit by staff – This is a change of ownership for an existing nonprofit service organization with on premise alcohol service located on the Northwest corner of South Virginia Street and Kumle Lane. The application is for a fraternal liquor license.*

**1. The Great Basin Community Food Cooperative, Amber Sallaberry, 240 Court Street - Dining Wine and Beer (For Possible Action) [Ward 5]**

- *Site visit by staff – This is an existing grocery store and café with dining room wine and beer service located on the Southeast corner of Court Street and Flint Street. The application is for a dining wine and beer license.*
